Bedside Fuel Fill, 67-72 C10 Pickup (Steel Bed Floor)

The Level 7 Motorsports Bedside Fuel Fill is a great solution for those looking to add a custom yet extremely functional fuel fill for their rear mounted fuel tank. This fuel fill is designed to work with 67-72 C10 pickups and can incorporate an optional dual chamber breather canister.

Product Information and installation.

This fuel fill is designed to be installed in the driver's side rear corner of the bed on a 1967-72 C10 pickup with a steel bed floor.


Step 1: You will need to cut out a section of the floor in order for the fill hose and vent hoses to pass through. Place the fuel fill in the corner, flush against the inner bed side and the stake pocket. We suggest using yellow tape on the bed floor so that you can mark the confines of the filler assembly. This will allow you to see where to keep your cut from being seen outside of the installed part. Please see the photos below for how we have done this on previous projects.





Step 2: Once you have located and cut the appropriate pass through in the floor you will once again need to place the fill against the bedside and mark the 5 mounting holes. Using a 23/64" Drill bit, drill out the holes and install the supplied ¼"-20 Rivet Nuts using a rivet gun. These are available from Harbor Freight (1210) or the one we use, Astro Pneumatic (1442) off of Amazon. Using the supplied ARP 12pt bolts, bolt the fuel fill to the bedside.

Connect your fill and vent hoses and check for any leaks.
